1. Your Most Recent Federal 1040 Income Tax Form
 - You must submit ALL pages of the 1040 Form of the person(s) claiming the student applicant as a dependent, even if that person does not live with you.
 - DO NOT submit your New Jersey State 1040 Form, as this form does not list your dependents.
2. 2009 W-2 Forms of both parents/guardians. If you have a 1099 Form instead of a W-2, you must submit that form.
3. **Documentation of any other income you received during 2009 must be included.**
